May kindly see the property statements online received from Smt Anchal Adhana, Civil Judge (Senior Division), Mathura regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-20(2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

(1) In the financial years 2018-20 (2018-19 & 2019-20), Total income from Salary and other Sources is Rs.19,07,884/- and total deductions/ repayment/ savings/ investment against GIS,INCOME TAX,CPF,CPFR, LOAN EMI,PPF is Rs.7,43,930. Thus, a sum of Rs.11,63,954/- was therefore available with her to meet out the household expenditure of her family for both the financial years. And the balance of her savings bank account(s) is also decreased for Rs.1,36,983/- this financial year from previous year's balance.

In this connection, it is submitted that the Officer has already submitted her property statements of the joining online against Case Id :P00002732020 (Old Case Id : 893) and same has been approved by the Hon'ble Mr. Justice Alok Singh, the then, Administrative Judge, Badaun.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20(2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. She has submitted movable and immovable property statements of the financial years 2018-20(2018-19 & 2019-20) vide online dated 10.12.2021. As such, there is delay in submitting the same from the part of the officer for which she has stated that "she has submitted the property statement according to the financial year 2018-19 vide offline letter no. 3605/I/Budaun dated 21-09-2019, instead of submitting the property statement held by her at the time of joining. After that she has submitted the property statement vide offline letter no. 4398/I/Budaun dated 22-11-2019,but mistakenly it was sent by offline mode. she has also sent information regarding property statement for the financial year 2018-20 vide letter no. 2048/I/Budaun dated 11.08.2021 but it was not sent by filling the details in the correct proform of 2018-2020 in e-service portal. She is highly regreted for the delay caused."

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Smt Anchal Adhana, Civil Judge (Senior Division), Mathura be laid before Hon'ble Mr. Justice Sanjay Kumar Singh, Administrative Judge, Mathura Judgeship for His Lordship's kind perusal and orders?
