May kindly see the property statements received from Sri Shiva Nand, Chief Judicial Magistrate, Ramabai Nagar regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2020-21 & 2021-22 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2020-21 & 2021-22 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2020-21 & 2021-22, Total income is Rs.38,18,997/- (Gross salary is Rs.33,67,427/-, Transfer T.A. of Rs.52,875/- and Bonds, FDR & reimbursements of Rs.3,98,695/-) and total deductions/ repayment/ savings/ investment (for both the financial years) against GPF/CPF, GIS, Income Tax, PPF, PLI, Home loans, Personal loan, Car loan and the balance of his savings bank account(s) is enhanced for Rs.1,92,813/- this financial year from previous year's balance, total of which is Rs.31,39,187/-. Thus, a sum of Rs.6,79,810/- was therefore available with him to meet out the household expenditure of his family consisting seven members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial year 2018-20 online which had already been seen online by Hon'ble Mr. Justice Ritu Raj Awasthi, the then Administrative Judge, Lucknow on e-service portal vide statement ID P00002792020.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2020-21 & 2021-22 in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements of the financial years 2020-21 & 2021-22 vide online dated 06.04.2022. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements of the financial years 2020-21 & 2021-22 (2020-22) of Sri Shiva Nand, Chief Judicial Magistrate, Ramabai Nagar be laid before Hon'ble Mr. Justice Saurabh Shyam Shamschery, Administrative Judge, Ramabai Nagar Judgeship for His Lordship's kind perusal and orders?
