

## **Registrar(J)(Budget)**

May kindly see the online property statement received from Sri Anshuman Yadav, Registrar, Land Acquisition Rehabilitation & Resettlement Authority, Varanasi regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2019-20 & 2020-21 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2019-20 & 2020-21 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2019-20 & 2020-21, Total Gross salary is Rs.12,63,620/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, Income Tax, Car loan, CM care and the balance of his savings bank account(s) is enhanced for Rs.37,643/- this financial year from previous year's balance, total of which is Rs.1,68,461/-. Thus, a sum of Rs.10,95,159/- was therefore available with him to meet out the household expenditure of himself in both the financial years.

It is pertinent to mention here that before Joining U.P Judicial Service on 29.11.2019, he was working as Assistant Legal Adviser in the Oil and Natural Gas Corporation of India. After resignation from service, the post-resignation benefits have been paid by the previous employer in year 2020, 2021, mentioned in remark column of movable proforma.

In this connection, it is submitted that the officer has already submitted his property statement at the time of joining into Judicial Service online which had already been seen online by Hon'ble Mr. Justice Salil Kumar Rai, the then Administrative Judge, Faizabad.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2019-20 & 2020-21 in its next financial year i.e., 2021-22 upto March 2022. He has submitted movable and immovable property statements of the financial years 2019-20 & 2020-21 firstly vide online dated 07.04.2022. As such, there is some day delay in submitting the same from the part of the officer for which he has stated that *"with utmost regards it is submitted before the Hon'ble court that delay took place in submission of the property statement. He tenders his apology with folded hands for the delay in submission of the same. Kindly place his apology before the Hon'ble Court"*, mentioned in his reply dated 01.08.2023.

May, therefore, if approved, property statements of the financial years 2019-20 & 2020-21 (2019-21) of Sri Anshuman Yadav, Registrar, Land Acquisition Rehabilitation & Resettlement Authority, Varanasi be laid before Hon'ble Mr. Justice Siddhartha Varma, Administrative Judge, Varanasi for His Lordship's kind perusal and orders?
