May kindly see the property statement submitted online received from Smt. Neha Anand, Additional District and Sessions Judge, Ambedkar Nagar at Akbarpur regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2010-12 (2010-11 & 2011-12) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2010-12 (2010-11 & 2011-12) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by her are given below.

In the financial year 2010-12 (2010-11 & 2011-12), her Total income from salary and 6th pay is Rs. 20,22,572/- (Salary Rs. 14,59,590/-, 6th pay Rs. 5,62,982/-) and total deductions/savings/investments against NPS, GIS, Income Tax, PPF and Shares is Rs. 5,27,018/- (including enhancement of Rs. 2,14,713/- in her S.B. A/cs against the balance of the previous year). Thus a sum of Rs. 14,95,554/- was therefore available with her to meet out the household expenditure of her family consisting of three members in both the financial years.

It is pertinent to mention here that the Officer's husband, Sri Ashish Varma is also Additional District and Sessions Judge (POCSO), Ambedkar Nagar at Akbarpur.

In this connection, it is submitted that the officer has already submitted her property statements offline for the financial year 2009-10 and seen by Hon'ble Mr. Justice Abdul Mateen, the then Administrative Judge, Gorakhpur.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit her property statements for the financial year 2010-12 (2010-11 & 2011-12) in its next financial year i.e., 2012-13 upto 31st March 2013. She has submitted movable and immovable property statements for the financial years 2010-12 (2010-11 & 2011-12) firstly vide her application dated 10.12.2020. As such, there is delay in submitting the same from the part of the officer and she has stated that the delay in submitting the property statements may please be condoned for which the undersigned seeks apology (can seen in the attachment titled 'Property Statement').

May, therefore, if approved, property statements for the financial years 2010-12 (2010-11 & 2011-12) of Smt. Neha Anand, Additional District and Sessions Judge, Ambedkar Nagar at Akbarpur, be laid before Hon'ble Mr. Justice Rajendra Kumar-IV, Administrative Judge, Ambedkar Nagar at Akbarpur for His Lordship's kind perusal and order?
