May kindly see the property statement received online from Sri Punit Mohan Das, Addl. Civil Judge (Junior Div.), Azamgarh regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2019-2021 (2019-20 & 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2019-2021 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2019-2021 (2019-20 & 2020-21), the Gross income from salary is Rs.13,08,456/- and total deductions/savings/investment against NPS, GIS, PPF, Car Loan repayments along with down payments and Income Tax is Rs.4,97,978/- and the balance of his savings bank account(s) is also decreased by Rs.4,229/- in this financial year from previous year's balance. Thus, a sum of Rs.8,14,707/- (Rs.8,10,478/- from salary and Rs.4,229/- from SB account) was therefore available with him to meet out the household expenditure of his family consisting of four member for the financial year 2019-2021 (2019-20 & 2020-21).

In this connection, it is submitted that the Officer has already submitted his property statement held at the time of joining into U.P. Judicial Service, online against Case Id : P00005252020 (Old Case Id : 1264) and the same has been seen by Hon'ble Mr. Justice Vivek Agarwal, the then Administrative Judge, Raebareli Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2019-2021 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. He has firstly submitted movable and immovable property statements of the financial year 2019-2021 (2019-20 & 2020-21) vide online dated 07.04.2022. As such, there is some delay in submitting the same from the part of the officer. In this regard, the Officer has stated (in the attachment dated 30.01.2023) that he joined the service in the month of November,2019 and submitted very first property statement at the time of joining the service, he was under apprehension that the next property statement has to be submitted after expiry of 2 years from the day of submission. Officer tenders unconditional apology and assures that the mistake will not be repeated in future.

May, therefore, if approved, property statements for the financial year 2019-2021 (2019-20 & 2020-21) of Sri Punit Mohan Das, Addl. Civil Judge (Junior Div.), Azamgarh, be laid before Hon'ble Mr. Justice Jayant Banerji, Administrative Judge, Azamgarh Judgeship for His Lordship's kind perusal and orders?
