May kindly see the property statement received online from Sri Saksham Dwivedi, Addl. Civil Judge (Sr.Div.)/ACJM, Meerut regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2020-22 (2020-21 & 2021-22) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2020-22 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2020-22 (2020-21 & 2021-22), Gross salary is Rs.19,61,177/- and total deductions/savings/repayment/investment against GIS, NPS, Income Tax, PPF, SIPs, Car loan and the balance of his savings bank account is also enhanced by Rs.79,114/- in this financial years from previous year's balance, total of which is Rs.8,51,765/-. Thus, a sum of Rs.11,09,412/- was therefore available with him to meet out the household expenditure of his family consisting two members in both of the financial years.

It is pertinent to mention here that his wife is also a Judicial officer having annual income of Rs. 11,00,000/- approx.

In this connection, it is submitted that the Officer has submitted his property statements upto the financial years 2018-20 and the same has already been seen online against Case Id : P00005492021 (Old Case Id : 2598) by Hon'ble Mr. Justice Salil Kumar Rai, the then Administrative Judge, Faizabad Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2020-22 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has submitted his movable and immovable property statements for the financial years 2020-22 (2020-21 & 2021-22) vide online dated 27.09.23. As such, there is delay in submitting the same from the part of the officer, for which 'the officer has apologised and stated to be mindful in future'.

May, therefore, if approved, property statements for the financial years 2020-22 (2020-21 & 2021-22) of Sri Saksham Dwivedi, Addl. Civil Judge (Sr.Div.)/ACJM, Meerut be laid before Hon'ble Mr. Justice Ajay Bhanot, Administrative Judge, Meerut Judgeship for His Lordship's kind perusal and orders?
