In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2015-17 (2015-16 & 2016-17) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2015-17 (2015-16 & 2016-17), his gross income from salary and arrears is Rs.24,37,906/- and total deductions/Savings/investments against NPS, GIS, Income Tax, PPF, Repayment of car loan and insurances is Rs.8,89,217/-. The balance of Rs.1,15,754/- has decreased from his saving bank a/cs against the balance of the previous year. Thus a sum of Rs.16,64,443/-(Rs.15,48,689/- from salary and Rs.1,15,754/- from saving bank account) was therefore available with him to meet out the household expenditure of his family consisting three members in the financial years 2015-17 (2015-16 & 2016-17).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial years 2013-15 (2013-14 & 2014-15) online against case id-P00057682022 and same has been processed before Hon'ble Mr. Justice Sanjay Kumar Pachori, Administrative Judge, Pilibhit for His Lordship's kind perusal and orders . \Box

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2015-17 (2015-16 & 2016-17) in its next financial year i.e., 2017-18 upto March 2018. He has submitted movable and immovable property statements of the financial years 2015-17 (2015-16 & 2016-17) vide online dated 05.04.2022. As such, there is delay in submitting the same. In this regard, officer verbatim: "This is humbly submitted that due to promotion in senior division cadre and then promotion in ADJ cadre ,transfer, covid 19 pandemic and excess of work the applicant could not send his property statement within stipulated time.Sir, I assure you that this will not be repeated in future. Kindly consider my sincere apology sympathetically and positively".

May, therefore, if approved, property statements for the financial years 2015-17 (2015-16 & 2016-17) of Sri Chandra Mohan Mishra, Special Judge (E.C. Act.), Pilibhit be laid before Hon'ble Mr. Justice Sanjay Kumar Pachori, Administrative Judge, Pilibhit for His Lordship's kind perusal and orders?
