May kindly see the property statement submitted online received from Smt. Neha Anand, Additional District and Sessions Judge, Ambedkar Nagar at Akbarpur regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2016-18 (2016-17 & 2017-18) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2016-18 (2016-17 & 2017-18) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by her are given below.

In the financial year 2016-18 (2016-17 & 2017-18), her Total income from salary is Rs. 26,03,546/- and total deductions/savings/investments against NPS, GIS, Income Tax, PPF, Insurances and Shares is Rs. 9,93,390/- Thus a sum of Rs. 16,10,156/- was therefore available with her to meet out the household expenditure of her family consisting of three members in both the financial years. And the balance of her savings bank account(s) is also reduced for Rs. 83,552/- this financial year from previous year's balance.

It is pertinent to mention here that the Officer's husband, Sri Ashish Varma is also Additional District and Sessions Judge (POCSO), Ambedkar Nagar at Akbarpur.

In this connection, it is submitted that the officer has already submitted her property statements online for the financial year 2014-16 (2014-15 & 2015-16) which is also processed online and laid before Hon'ble Mr. Justice Jaspreet Singh, Administrative Judge, Ambedkar Nagar at Akbarpur for his Lordship's kind perusal and order on e-service Id no. 804.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit her property statements for the financial year 2016-18 (2016-17 & 2017-18) in its next financial year i.e., 2018-19 upto 31st March 2019. She has submitted movable and immovable property statements for the financial years 2016-18 (2016-17 & 2017-18) firstly vide her application dated 28.02.2020. As such, there is delay in submitting the same from the part of the officer and she has stated that the delay in submitting the property statements may please be condoned for which the undersigned seeks apology (can be seen in the attachments titled 'Property Statment').

May, therefore, if approved, property statements for the financial years 2016-18 (2016-17 & 2017-18) of Smt. Neha Anand, Additional District and Sessions Judge, Ambedkar Nagar at Akbarpur, be laid before Hon'ble Mr. Justice Rajendra Kumar-IV, Administrative Judge, Ambedkar Nagar at Akbarpur for His Lordship's kind perusal and order?
