It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2008-10 (2008-09 & 2009-10) in its next financial year i.e., 2010-11 upto March 2011. He has submitted movable and immovable property statements of the financial year 2008-10 (2008-09 & 2009-10) vide online dated 09.04.2022. As such, there is delay in submitting the same. In this regard, officer has not given any reason.
