May kindly see the property statement received online from Smt. Manali Chandra, Judicial Magistrate, Sultanpur regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2019-2021 (2019-20 & 2020-21) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial year 2019-2021 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

In the financial year 2019-2021 (2019-20 & 2020-21), the Gross income from salary is Rs.10,94,020/- and total deductions/ repayment/ savings/ investment against GIS, NPS, Income Tax, PPF and Loan Repayment are Rs.3,61,782/-. Thus, a sum of Rs.7,32,238/- was therefore available with her to meet out the household expenditure of her family consisting two members of the financial year 2019-2021 (2019-20 & 2020-21) and the balance of her savings bank account is also decreased by Rs.30,718/- in this financial year from previous year's balance.

It is pertinent to mention here that her husband is Government Employee having Basic Rs.76,200/- as on 31.03.2021 (as mentioned by the officer).

In this connection, it is submitted that the officer has already submitted her movable and immovable property statements held at the time of Joining into U.P. Judicial Service online against Case id: P00000732021 (Old Case Id : 2035) and the same has been seen by Hon'ble Mr. Justice Vivek Kumar Birla, the then Administrative Judge, Allahabad Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial year 2019-2021 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. She has firstly submitted movable and immovable property statements of the financial year 2019-2021 (2019-20 & 2020-21) vide online dated 08.04.2022. As such, there is some day delay in submitting the same from the part of the officer for which she has stated in her online reply dated 30.03.2024, that she was blessed with a baby girl on 06.12.2021 and was on maternity leave thereafter. Further, her condition was not well at the time of cut-off date for the submission of property statement i.e. 31.03.2022. She filled the statement as soon as her health condition improved. Therefore, she humbly request to condone the delay.

May, therefore, if approved, property statements for the financial year 2019-2021 (2019-20 & 2020-21) of Smt. Manali Chandra, Judicial Magistrate, Sultanpur, be laid before Hon'ble Mr. Justice Irshad Ali, Administrative Judge, Sultanpur Judgeship for His Lordship's kind perusal and orders?
