

## **Registrar(J)(Budget)**

May kindly see the online property statements received from Sri Umesh Chandra Pandey-II, Special Judge (E.C.Act), Barabanki regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2014-15 and 2015-16 (2014-16) in the prescribed proforma to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2014-15 and 2015-16 (financial years 2014-16) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2014-15 & 2015-16 (2014-16), Total Gross income from salary are Rs.25,12,189/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GPF, GIS, Income Tax, Home loan, Insurance policies, PPF, Car loan and the balance of his savings bank account(s) is also enhanced for Rs.18,919/- this financial year from previous year's balance, total of which is Rs.18,93,714/-. Thus, a sum of Rs.6,18,475/- was therefore available with him to meet out the household expenditure of his family consisting five members in both the financial years.

It is pertinent to mention here that officer has also mentioned regarding his household expenses in his reply that "his father was a retired senior pensioner judicial officer from the Central Industrial Tribunal, New Delhi, who lived with him due to his old age and also made financial contributions out of natural love and affection. He died on 01.03.2016 while being with him. Joint family farming is also done on the ancestral agricultural land of his village in which various crops like sugarcane, wheat etc. are grown which provides additional support to the household expenses. Due to his simple lifestyle, he does not have the habit of unnecessary expenses. His family expenses are very limited as compared to his income".

In this connection, it is submitted that the officer has already submitted his property statement upto the financial year 2013-14 which had already been seen by Hon'ble Mr. Justice Shree Prakash Singh, Administrative Judge, Barabanki, placed in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2014-15 & 2015-16 in its next financial year i.e., 2016-17 upto March,2017. Officer has submitted the same firstly vide online dated 14.04.2022. As such, there is delay in submitting the same from the part of the officer for which he has stated that "*after his father's death, the details could not be presented at that time due to being busy in the funeral and due to non-availability of details of emoluments to be received in the subsequent succession. So the statements has been submitted with delay after availability of required details*", mentioned in his reply dated 08.11.2023.

May, therefore, if approved, property statements of the financial years 2014-15 & 2015-16 (2014-16) of Sri Umesh Chandra Pandey-II, Special Judge (E.C.Act), Barabanki be laid before Hon'ble Mr. Justice Shree Prakash Singh, Administrative Judge, Barabanki Judgship for His Lordship's kind perusal and orders?
