May kindly see the online property statements received from Sri Umesh Chandra Pandey-II, Special Judge (E.C.Act), Barabanki regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2016-17 & 2017-18 (financial year 2016-18) in the prescribed proforma to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2016-17 & 2017-18 (financial year 2016-18) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2016-17 & 2017-18 (financial year 2016-18), total income is Rs.39,86,331 (Gross income from Salary are Rs.31,90,743/- and amount received after death of his father from his savings of Rs.7,95,588/-) and total deductions/ repayment/ savings/ investment (for both the financial years) against GPF, GIS, Income Tax, Insurance policy, Home loan, Car loan, PPF and the balance of his savings bank account(s) has enhanced for Rs.10,89,211/- this financial year from previous year's balance, total of which is Rs.33,11,838/-. Thus, a sum of Rs.6,74,493/- was therefore available with him to meet out the household expenditure of his family consisting five members for both the financial years.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial year 2013-14 which had already been seen by Hon'ble Mr. Justice Shree Prakash Singh, Administrative Judge, Barabanki, placed in the misc. file of the officer. Online detailed note related to property statement of the financial years 2014-16 has already been submitted on e-service ID P00058712022.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2016-17 & 2017-18 (financial year 2016-18) in its next financial year i.e., 2018-19 upto March 2019. Officer has submitted the same firstly vide online letter dated 14.04.2022. As such, there is delay in submitting the same from the part of the officer for which he has stated that *"due to the death of his father, the details of the properties to be inherited were not available, so the property details could not be submitted on time. The details of the properties to be inherited were not available in various banks and revenue offices. There was a delay in obtaining that records"*, mentioned in his reply dated 08.11.2023

May, therefore, if approved, property statements of the financial years 2016-17 & 2017-18 (2016-18) of Sri Umesh Chandra Pandey-II, Special Judge (E.C.Act), Barabanki be laid before Hon'ble Mr. Justice Shree Prakash Singh, Administrative Judge, Barabanki Judgship for His Lordship's kind perusal and orders?
