May kindly see the online property statement received from Sri Umesh Chandra Pandey-II, Special Judge (E.C.Act), Barabanki regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2018-19 & 2019-20 (financial year 2018-20) in the prescribed proforma to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years financial years 2018-19 & 2019-20 (financial year 2018-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2018-19 & 2019-20 (financial year 2018-20), total income is Rs.70,37,343/-(Gross income from salary is Rs.54,94,545/-, Arrear of IR of Rs.4,77,234/-, ACP arrear of Rs.41,466/- and LLM's three advance increments of Rs.10,24,098/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GPF, GIS, Income Tax, Home loan, Car loans, PPF, Insurance policy, amount paid against purchase of another Car and the balance of his savings bank account(s) is enhanced for Rs.4,33,257/- this financial year from previous year's balance, total of which is Rs.46,66,620/-. Thus, a sum of Rs.23,70,723/- was therefore available with him to meet out the household expenditure of his family consisting five members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial year 2013-14 which had already been seen by Hon'ble Mr. Justice Shree Prakash Singh, Administrative Judge, Barabanki, placed in the misc. file of the officer. Online detailed notes related to property statement of the financial years 2014-16 and 2016-18 have already been submitted online eservice IDs P00058712022 and P00058732022 respectively.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2018-19 & 2019-20 (financial year 2018-20) in the next financial year i.e., 2020-21 upto March 2021. Officer has submitted the same firstly online on 14.04.2022. As such, there is delay in submitting the same from the part of the officer for which he has stated that "he did not intentionally cause any delay in sending the property details of the financial years, but due to the Covid 2019 pandemic, most of the government offices were closed for several months and due to the death of his father, the details of the inherited properties were not available. Due to which the property details could not be submitted on time. There was a delay in receiving the records from the revenue offices detailing the properties received through inheritance, the amount invested in various banks and schemes." mentioned in his reply dated 08.11.2023.

May, therefore, if approved, property statements of the financial years 2018-19 & 2019-20 (financial year 2018-20) of Sri Umesh Chandra Pandey-II, Special Judge (E.C.Act), Barabanki be laid before Hon'ble Mr. Justice Shree Prakash Singh, Administrative Judge, Barabanki Judgeship for His Lordship's kind perusal and orders?
