May kindly see the property statement received online from Sushri Shinjini Yadav, Judicial Magistrate, Bhadohi at Gyanpur regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family of the financial years 2019-21 (2019-20 & 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2019-21 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2019-21 (2019-20 & 2020-21), Gross income from salary is Rs.13,93,374/- and total deductions/savings/repayment/investment against GIS, NPS, Income Tax, PPF, car down payment & loan EMI and the balance of her saving bank account is also enhanced by Rs.2,82,000/- in this financial year from previous year's balance, total of which is Rs.10,29,814/-. Thus, a sum of Rs.3,63,560/- was therefore available with her to meet out her household expenditure in both of the financial years. It is pertinent to mention here that officer's father is a retired class one officer whose monthly pension is Rs.96,000/- and her mother's annual income is Rs. 12 lakh from service, as mentioned by the officer.

In this connection, it is submitted that the Officer has submitted her property statement held at the time of joining into U.P. Judicial Service and the same has been approved online against Case Id : P0006542020 by Hon'ble Mr. Justice Vivek Agarwal, the then Administrative Judge, Rae Bareilly Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2019-21 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. She has firstly submitted her movable and immovable property statements for the financial years 2019-21 (2019-20 & 2020-21) vide online dated 06.04.2022. As such, there is a delay of six days in submitting the same from the part of the officer. In this regard, she has stated (in her verbatim) that "most humbly I beg to state that due to unavoidable circumstances there was a difficulty in obtaining the requisite car loan documents from the bank concerned and the salary statements due to which it took a little time to file records and respond to previous objections. I most respectfully seek apology for the same and assure that in future it will not be repeated. I shall ever pray for this act of kindness".

May, therefore, if approved, property statements for the financial years 2019-21 (2019-20 & 2020-21) of Sushri Shinjini Yadav, Judicial Magistrate, Bhadohi at Gyanpur be laid before Hon'ble Mr. Justice Mohd. Azhar Husain Idrisi, Administrative Judge, Bhadohi at Gyanpur Judgeship for His Lordship's kind perusal and orders?
