May kindly see the online property statement received from Sri Umesh Chandra Pandey-II, Special Judge (E.C.Act), Barabanki regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2020-21 & 2021-22 (financial year 2020-22) in the prescribed proforma to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2020-21 & 2021-22 (financial year 2020-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2020-21 & 2021-22 (financial year 2020-22), total Gross income from Salary are Rs.50,59,375/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GPF, GIS, Income Tax, PPF, LIC Home loan, Car loan and the balance of his savings bank account(s) is enhanced for Rs.13,66,094/- this financial year from previous year's balance, total of which is Rs.47,59,461/-. Thus, a sum of Rs.2,99,914/- was therefore available with him to meet out the household expenditure of his family consisting five members in both the financial years.

It is pertinent to mention here that the officer has submitted that the ancestral joint family of his village also do farming on the agricultural land in which various crops are grown, which also provides additional support to the household expenses. Due to his simple lifestyle, he does not have the habit of unnecessary expenses. He has a small family and a balanced life. Additional funds were also received from time to time as per rules in the form of leave encashment and dress allowance, transfer TA etc. and money was also returned from time to time from investment made in life insurance, which was used for personal and family expenses, mentioned in his reply dated 08.11.2023.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial year 2013-14 which had already been seen by Hon'ble Mr. Justice Shree Prakash Singh, Administrative Judge, Barabanki, placed in the misc. file of the officer. Online detailed notes related to property statement of the financial years 2014-16, 2016-18 and 2018-20 have already been submitted on e-service ID P00058712022, P00058732022 and P00058742022 respectively.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2020-21 & 2021-22 in the next financial year i.e., 2022-23 upto March 2023. Officer has submitted the same online on 14.04.2022. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements of the financial years 2020-21 & 2021-22 of Sri Umesh Chandra Pandey-II, Special Judge (E.C.Act), Barabanki be laid before Hon'ble Mr. Justice Shree Prakash Singh, Administrative Judge, Barabanki Judgeship for His Lordship's kind perusal and orders?
