May kindly see the online request dated 11.04.2022 received from Smt. Sangeeta Srivastava, District & Sessions Judge, Kannauj regarding submission of statements of movable and immovable properties for the financial years 2020-22 (2020-21 and 2021-22) on proforma to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2020-22 (2020-21 and 2021-22) of the Officer concerned, details of income, deductions, savings, investment and expenditure made by her are given below.

1. In the financial years 2020-22 (2020-21 and 2021-22), her gross income is Rs. 67,85,283 /- (Income from salary is Rs. 60,25,283/- & Income from House Rent is Rs. 7,60,000/-) and total deductions/Savings/investments against GPF, GIS, Income Tax, PPF and LIC is Rs. 48,17,407/- (including enhancement of balance of Rs. 20,78,765/- in her saving bank A/cs against the balance of the previous year). Thus a sum of Rs.19,67,876/- was therefore available with her to meet out the household expenditure of her in the financial years 2020-22 (2020-21 and 2021-22).

It is pertinent to mention that Sri Ajai Kumar Srivastava (husband) is a P.O. M.A.C.T, in Kanpur Nagar, whose annual income is Rs.30,35,773/-, Kartikeya (son) working in indian railway income Rs 10 lakh yearly, Arpit Srivastava ( son) working in IBM Co. income 29 lakh yearly.

In this connection it is submitted that the officer has already submitted her property statements upto the financial year 2018-20 which have already been seen online by Hon'ble Mr. Justice Rakesh Srivastava, the then Administrative Judge, Faizabad, on old case ID no.1381.

The movable and immovable property statement for the financial years 2020-22 (2020-21 and 2021-22) has been submitted by the Officer vide her online dated 11.04.2022 which is due to be submitted upto the end of the financial year 2022-23 as per two year block policy. As such, there is no delay in submitting the property statements from the part of the officer.

May, if approved, the movable and immovable property statements for the financial years of Smt. Sangeeta Srivastava, District & Sessions Judge, Kannauj 2020-22 (2020-21 and 2021-22) be laid before Hon'ble Mr. Justice Ajai Kumar Srivastava-I, Administrative Judge, Kannauj Judgeship for His Lordship's kind perusal and orders?
