May kindly see the property statement received online from Sri Pushpendra Singh, Addl. Civil Judge (Junior Div.), Bahraich, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2019-2021 (2019-20 & 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2019-2021 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2019-2021 (2019-20 & 2020-21), the Gross income is Rs.13,61,955/-(Rs.12,75,955/- from salary and Rs.86,000/- from redeemed Nippon India Fund) and total deductions/savings/investment against NPS, GIS, PPF, Covid Fund, Loan repayments including amount paid other than loan,SIPs/Funds and Income Tax is Rs.8,86,408/-. Thus, a sum of Rs.4,75,547/- was therefore available with him to meet out the household expenditure of his family consisting four members of the financial year 2019-2021 (2019-20 & 2020-21) and the balance of his savings bank account(s) is also decreased by Rs.45,556/- in this financial year from previous year's balance. It is pertinent to mention here that his wife, Mrs. Tanendra Kaur have annual income of Rs.1,00,000/approx. from Agriculture (as mentioned by officer).

In this connection, it is submitted that the Officer has already submitted his property statement held at the time of joining online against Case Id : P00005142021 (Old Case Id : 2560) and the same has been seen by Hon'ble Mr. Justice Attau Rahman Masoodi, the then Administrative Judge, Bareilly Judgeship. It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2019-2021 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. He has submitted movable and immovable property statements of the financial year 2019-2021 (2019-20 & 2020-21) in the remark column of movable proforma, that (in his verbatim) *"I have joined as Civil Judge (J.D.) Bareilly on 23.11.2019. In compliance of Hon'ble High Court's directives the undersigned had submitted the statement of movable and immovable property at the time of entering the Judicial service on E-portal vide application no 2560 (new no. P00005142021) dated 11.10.2021, which is approved by the Hon'ble Court on 16.12.2021. I was under impression that the next due date for property statement is 1st April, 2022. Kindly forgive the delay. I assure to Hon'ble that the statement of movable and immovable property in future shall be filed within stipulated time limit."*

Civil Judge (Junior Div.), Bahraich, be laid before Hon'ble Mr. Justice Raj Beer Singh, Administrative Judge, Bahraich Judgeship for His Lordship's kind perusal and orders?
