May kindly see the online property statements received from Sri Hemendra Singh, Nyayadhikari, Gram Nyayalaya, Kaushambi regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2019-21 (2019-20 & 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2019-2021 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings, investment and expenditure made by him are given below:

(1) In the financial years 2019-20 (14.11.2019 to 31.03.2020) & 2020-21, total Gross income from salary is Rs.12,97,955/- and total deduction/ repayment/ savings/ investment/ against G.I.S., P.P.F., NPS, Income Tax, Car loan, CM Covid fund, Insurance policies and the balance of his savings bank account has also been enhanced for Rs.22,523/- this financial year from previous year's balance, total of which is Rs.6,32,361/-. Thus, a sum of Rs.6,65,594/- was available with him to meet out the household expenditure of himself for one year three months of the financial years 2019-2021 (2019-20 & 2020-21).

In this connection, it is submitted that officer has already submitted his property statement at the time of joining online, which had already been seen online by Hon'ble Mr. Justice Attau Rahman Masoodi, the then Administrative Judge, Bareilly.

It is submitted that as per policy/Court's Circular letter, the officer has to submit his property statement for the financial years 2019-21 (2019-20 & 2020-21) in its next financial year i.e. 2021-22 upto March, 2022. He has submitted movable and immovable property statements of the financial years 2019-21 firstly vide online letter dated 10.04.2022. As such, there is delay in submitting the same from the part of the officer for which he has stated (in his verbatim) that *"Due to being newly in the service and little experience, the undersigned was under impression that the next due movable and immovable property statement is to be submitted after 01 April 2022. Therefore, Hon'ble Court is requested to kindly forgive the delay in giving statement of movable and immovable property by the undersigned. I assure the Hon'ble Court that the statement of movable and immovable property in future shall be filed within stipulated time limit"*, mentioned in remark column of movable proforma.

May, therefore, if approved, property statements for the financial years 2019-21 (2019-20 & 2020-21) of Sri Hemendra Singh, Nyayadhikari, Gram Nyayalaya, Kaushambi be laid before Hon'ble Mr. Justice Surendra Singh-I, Administrative Judge, Kaushambi for His Lordship's kind perusal and orders?
