May kindly see the property statement received online from Smt. Sapna Tripathi-I, Spl. J. (SC/ST, Pev.of Atroci Act), Hardoi, regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2020-2022 (2020-21 & 2021-22) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial year 2020-2022 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

In the financial year 2020-2022 (2020-21 & 2021-22), the Gross income is Rs.50,03,207/- (Rs.45,91,929/- from Salary and Rs.3,66,666/- & Rs.44,612/- from maturity of SBI policy and L&T Certificate respectively) and total deductions/ repayment/ savings/ investment against GIS, GPF, NPS, PPF, Sukanya Samriddhi Account, SBI policies, loan repayments and Income Tax are Rs.43,17,726/- and the balance of her savings bank account is also increased by Rs.466/- in this financial year from previous year's balance, total of which is Rs.43,18,192/-. Thus, a sum of Rs.6,85,015/- was therefore available with her to meet out the household expenditure of her family consisting four members in the both financial year.

It is pertinent to mention here that her husband, working as Deputy General Manager, NTPC, have gross income of Rs.39,45,362/- & Rs.38,38,563/- in financial year 2020-21 & 2021-22 respectively.

In this connection, it is submitted that the officer has already submitted her movable and immovable property statements of the financial year 2018-2020 (2018-19 & 2019-20), online against Case Id : P00007992020 (Old Case Id : 1652) and the same has been seen by Hon'ble Mr. Justice Ritu Raj Awasthi, the then Administrative Judge, Lucknow Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial year 2020-2022 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. She has submitted movable and immovable property statements of the financial year 2020-2022 (2020-21 & 2021-22) vide online dated 08.04.2022. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial year 2020-2022 (2020-21 & 2021-22) of Smt. Sapna Tripathi-I, Spl. J. (SC/ST, Pev.of Atroci Act), Hardoi, be laid before Hon'ble Mrs. Justice Manju Rani Chauhan, Administrative Judge, Hardoi Judgeship for Her Lordship's kind perusal and orders?
