May kindly see the property statement online received from Sri Punit Kumar Gupta, Addl. In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2018-20 (2018-19 & 2019-20), Total income is Rs.47,20,010/- (Gross income from salary ) and total deductions/ repayment/ savings/ investment against GPF, GIS, Income Tax, PPF, Insurences, are Rs.28,04,367/-. Thus, a sum of Rs.19,15,643/- was available with him to meet out the household expenditure of his family consisting five members in both of the financial years and the balance of his savings bank account(s) is decreased by Rs.64,408/- this financial year from previous year's balance.

It is pertinent to mention here that wife of the officer is an Advocate & her income is approx Rs.2,50,000/- per annual.

In this connection, it is submitted that the officer has already submitted his property statements of the financial years 2016-18 which are currently processed online on Case Id: P00000062023 before Hon'ble Mr. Justice Dinesh Kumar Singh, Administrative Judge, Moradabad for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-20 (2018-19 & 2019-20) firstly vide online dated 08.04.2022. As, there is delay in submitting aforesaid property statements from the part of the officer and Officer has not given any reason for delay.

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sri Punit Kumar Gupta, Addl. District & Sessions Judge, Moradabad be laid before Hon'ble Mr. Justice Dinesh Kumar Singh, Administrative Judge, Moradabad for His Lordship's kind perusal and orders?
