May kindly see the property statements online received from Sri Amarendra Kumar Verma, Addl. Civil Judge, (Junior Div.), Saharanpur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2019-20 & 2020-21 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2019-20 & 2020-21 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2019-20 & 2020-21 , Total income from salary are Rs.11,73, 368/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, NPS, Income Tax, PPF, car loan and the balance of his savings bank account(s) is enhanced for Rs.93,927/- this financial year from previous year's balance, total of which is Rs.4,69,842/-. Thus, a sum of Rs.7,03,526/- was therefore available with him to meet out the household expenditure of his family consisting two members in both the financial years.

It is pertinent to mention here that his wife is working as Senior Officer, Yes Bank, Kanpur having annual income of Rs.7,50,000/-.

In this connection, it is submitted that officer has already submitted his property statement held at the time of joining into judicial service online against case id-P00004352021 (Old case Id-2465), and same has been submitted before Hon'ble Mr. Justice Neeraj Tiwari, Administrative Judge, Saharanpur Judgship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2019-20 & 2020-21 in its next financial year i.e., 2021-22 upto March 2022. He has submitted movable and immovable property statements of the financial years 2019-20 & 2020-21 vide online dated 13.04.2022. As such, there is some delay in submitting the same from the part of the officer for which he has stated that "after joining the service on 16-12-2019, I have submitted my property statement on 07-04-2021 for the first time. But I could not submit the statement fo properties held upto the financial year 2019-20 earlier due to lack of knowledge. I apologize for not submitting property statement on time. Hence, It is therefore requested kindly to accept my apologizes for delay", mentioned in his attachment dated 10.04.2022.

May, therefore, if approved, property statements of the financial year 2019-20 & 2020-21 of Sri Amarendra Kumar Verma, Addl. Civil Judge, (Junior Div.), Saharanpur be laid before Hon'ble Mr. Justice Neeraj Tiwari, Administrative Judge, Saharanpur Judgship for His Lordship's kind perusal and orders?
