May kindly see the property statement online received from Smt. Akshita, Civil Judge (Junior Div.), Mohammadi-Lakhimpur regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family of the financial years 2019-21 (2019-20 and 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2019-21 (2019-20 and 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

In the financial years 2019-21 (2019-20 and 2020-21), her gross income from salary is Rs.12,75,955/- and total deductions/Savings/investments NPS, GIS, Income Tax and Car loan and down-payment are Rs.6,45,748/-. The balance of Rs.90,107/- has increased from her saving bank A/c's against the balance of the previous year. Thus a sum of Rs.6,30,207/- was therefore available with her to meet out the household expenditure of herself for the financial years 2019-21 (2019-20 and 2020-21).

In this connection, it is submitted that the Officer has already submitted her property statement held at the time of Joining in to U.P. Judicial Service online against case id:P00009672021 (old case id:3050), which had already been seen by Hon'ble Mr. Justice Attau Rahman Masoodi, the then Administrative Judge, Bareilly Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2019-21 (2019-20 and 2020-21) in its next financial year i.e., 2021-22 upto March 2022. She had submitted movable and immovable property statements for the financial years 2019-21 (2019-20 and 2020-21) vide online dated 11.04.2022 on eServicesJo portal. As such, there is only 11 days delay in submitting the same." In this regard, officer verbatim: The reason of delay submission of the statement is that I have joined the services on 16-12-2019 I have submitted my statement of 2019-2021 at the time of joining which is already been approved on dated 15-12-2021. I was under the impression that the next property statement is to be submitted in the year of 2021-2022. Kindly consider my request. I will be highly obliged.

Mohammadi-Lakhimpur be laid before Hon'ble Mr. Justice Pankaj Bhatia, Administrative Judge, Lakhimpur Kheri Judgeship for His Lordship's kind perusal and orders?
