May kindly see the property statement online received from Sri Alok Pandey, Additional District & Sessions Judge, Ghaziabad regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2020-22 (2020-21 & 2021-22) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2020-22 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings, investment and expenditure made by him are given below:

In the financial years 2020-22 (2020-21 & 2021-22), total income is Rs.48,07,212/- (Income from salary Rs. 45,10,909/- and Income from LIC Rs. 2,96,303/-) and total deduction/ repayment/ savings/ investment/ against G.P.F., G.I.S., Income Tax, P.P.F. (approx.), repayment of home loan, Insurances and the balance of his savings bank account(s) is enhanced by Rs.6,38,701/- this financial year from previous year's balance, total of which is Rs.37,81,718/- . Thus, a sum of Rs.10,25,494/- was available with him to meet out the household expenditure of his family consisting three members for the financial year 2020-22 (2020-21 & 2021-22).

In this connection, it is further submitted that officer has already submitted his property statement for the period of 2018-20 which had already been processed before Hon'ble Mr. Justice Attau Saumitra Dayal Singh, Administrative Judge, Ghaziabad on old case Id no-4525.

It is again submitted that as per policy/Court's Circular letter, the officer has to submit his property statement for the financial years 2020-22 (2020-21 & 2021-22) in its next financial year i.e. 2022-23 upto March, 2023. He has submitted movable and immovable property statements of the financial years 2020-22 (2020-21 & 2021-22) vide online letter dated 12.04.2022. As such, there is delay in submitting the aforesaid property statements from the part of officer for which he has not mention any reason for delay submission.

May, therefore, if approved, property statements for the financial years 2020-22 (2020-21 & 2021-22) of Sri Alok Pandey, Additional District & Sessions Judge, Ghaziabad be laid before Hon'ble Mr. Justice Saumitra Dayal Singh, Administrative Judge, Ghaziabad for His Lordship's kind perusal and orders?
