May kindly see the property statement received online from Sri Mohd Suhail, Nyayadhikari, Gram Nyayalaya, Chauri Chaura-Gorakhpur, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2019-21 (2019-20 & 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2019-21 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial year 2019-21 (2019-20 & 2020-21), the Gross income from salary is Rs. 12,29,456/- and total deductions/savings/investment against NPS, GIS, Income Tax is Rs.1,97,224/- and the balance of his savings bank account(s) is also enhanced by Rs.1,73,372/- in this financial year from previous year's balance, total of which is Rs.3,70,596/-. Thus, a sum of Rs. 8,58,860/- was therefore available with him to meet out the household expenditure of his family consisting two members of the financial year 2019-21 (2019-20 & 2020-21).

It is also pertinent to mention here that the officer's wife Mrs. Sumbul Irshad is a Judicial Officer whose total income from salary is Rs.15,68,995/- in the financial year 2019-21 (2019-20 & 2020-21). .

In this connection, it is submitted that the Officer has already submitted his property statement at the time of joining online against Case Id : P00028222021 (Old Case Id :4963) and the same has been processed before Hon'ble Mr. Justice Shekhar B. Saraf, Administrative Judge, Gorakhpur Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2019-21 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. He has submitted movable and immovable property statements of the financial year 2019-21 (2019-20 & 2020-21) vide online dated 16.04.2022. As such, there is some delay in submitting the same from the part of the officer. In this regard, the officer has not given reason for delay.

May, therefore, if approved, property statements for the financial year 2019-21 (2019-20 & 2020-21) of Sri Mohd Suhail, Nyayadhikari, Gram Nyayalaya, Chauri Chaura-Gorakhpur, be laid before Hon'ble Mr. Justice Shekhar B. Saraf, Administrative Judge, Gorakhpur Judgeship for His Lordship's kind perusal and orders?
