May kindly see the property statement received online from Sushri Pomela Srivastava, Addl. Civil Judge (Sr.Div.)/ACJM., Sultanpur regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial year 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

In the financial year 2018-20 (2018-19 & 2019-20), the Gross income from salary is Rs. 16,95,316/- and total deductions/ repayment/ savings/ investment against GIS, PPF, NPS, Income Tax, down payment and car loan are Rs.7,28,940/- and the balance of her savings bank account is also enhanced by Rs. 20,724/- in this financial year from previous year's balance, total of which is Rs.7,49,664/-. Thus, a sum of Rs. 9,45,652/- was therefore available with her to meet out the household expenditure of her family consisting two members of the financial year 2018-20 (2018-19 & 2019-20).

It is also pertinent to mention here that the Officer's mother is a retired government employee (at present pensioner).

In this connection, it is submitted that the officer has already submitted her property statement held at the time of entering i.e., of joining into U.P. Judicial Service online against Case Id : P00001102020 (Old Case Id : 685), which has been seen by Hon'ble Mr. Justice Pankaj Naqvi, the then Administrative Judge, Pilibhit.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial year 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. She has submitted movable and immovable property statements of the financial year 2018-20 (2018-19 & 2019-20) vide online dated 16.04.2022. As such, there is delay in submitting the same from the part of the officer. In this regard, officer has given reason of delay (in her verbatim), as under:

"It is humbly submitted that due to lack of proper knowledge regarding circular letter related to submission of property statement. I had chosen wrong financial year while submitting my statement on 04/12/2021. The abovementioned mistake was bonafide and unintentional. As soon as i came to know regarding the abovementioned mistake, i withdrew that property statement and now i am submitting the correct statement. I humbly apologise for delay in submission of this statement. I will make sure that i submit all my statements within stipulated timeperiod."

May, therefore, if approved, property statements for the financial year 2018-20 (2018-19 & 2019-20) of Sushri Pomela Srivastava, Addl. Civil Judge (Sr.Div.)/ACJM., Sultanpur, be laid before Hon'ble Mr. Justice Irshad Ali, Administrative Judge, Sultanpur Judgeship for His Lordship's kind perusal and orders?
