May kindly see the property statement received online from Sushri Pomela Srivastava, Addl. Civil Judge (Sr.Div.)/ACJM., Sultanpur regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2020-22 (2020-21 & 2021-22) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial year 2020-22 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

In the financial year 2020-22 (2020-21 & 2021-22), the Gross income from salary is Rs. 21,91,289/- and total deductions/ repayment/ savings/ investment against GIS, PPF, NPS, Income Tax, and car loan are Rs.8,59,061/- and the balance of her savings bank account is also reduced by Rs.16,087/- in this financial year from previous year's balance. Thus, a sum of Rs. 13,48,315/- was therefore available with her to meet out the household expenditure of her family consisting two members in the financial year 2020-22 (2020-21 & 2021-22).

It is also pertinent to mention here that the Officer's mother is a retired government employee (at present pensioner).

In this connection, it is submitted that the officer has already submitted her movable and immovable property statements of the financial year 2018-19 & 2019-20, online against Case Id : P00059522022 and the same has been processed before Hon'ble Mr. Justice Irshad Ali, Administrative Judge, Sultanpur Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial year 2020-22 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. She has submitted movable and immovable property statements of the financial year 2020-22 (2020-21 & 2021-22) vide online dated 16.04.2022. As such, there is no delay in submitting the same .

May, therefore, if approved, property statements for the financial year 2020-22 (2020-21 & 2021-22) of Sushri Pomela Srivastava, Addl. Civil Judge (Sr.Div.)/ACJM., Sultanpur, be laid before Hon'ble Mr. Justice Irshad Ali, Administrative Judge, Sultanpur Judgeship for His Lordship's kind perusal and orders?
