May kindly see the property statements online received from Sri Rajeev Kumar Pal, Additional Civil Judge(Jr.Div.), Shahjahanpur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2019-20 & 2020-21(i. e. from 13.12.2019 to 31.3.20 and from 1.4.20 to 31.3.2021) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2019-20 & 2020-21(i. e. from 13.12.2019 to 31.3.20 and from 1.4.20 to 31.3.2021) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2019-20 & 2020-21(i. e. from 13.12.2019 to 31.3.20 and from 1.4.20 to 31.3.2021)12,11,100, total Gross salary is Rs.12,11,100/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, PRAN, Insurance policies, Income Tax and repayment of loans are Rs. 6,53,610/-. Thus, a sum of Rs.5,57,490/- was therefore available with him to meet out the household expenditure of his family consisting three members in both the financial years. And the balance of his savings bank account(s) is reduced for Rs.42,042/- this financial year from previous year's balance.

In this connection, it is submitted that the officer has already submitted his property statement at the time of entering into judicial service which had been processed on Case ID no. Pooo22952021.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2019-20 & 2020-21 in its next financial year i.e., 2021-22 upto March 2022. He has submitted movable and immovable property statements of the financial years 2019-20 & 2020-21 firstly vide online dated 22.042022. As such, there is delay in submitting the same from the part of the officer for which he has say extremely sorry for the same.

May, therefore, if approved, property statements of the financial years 2019-20 & 2020-21 (i. e. from 13.12.2019 to 31.3.20 and from 1.4.20 to 31.3.2021)of Sri Rajeev Kumar Pal, Additional Civil Judge(Jr.Div.), Shahjahanpur be laid before Hon'ble Mr. Justice Neeraj Tiwari, Administrative Judge, Shahjahanpur Judgship for His Lordship's kind perusal and orders?
