May kindly see the property statement online received from Smt. Chandra Sheela, Principal Judge, Family Court, Basti regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family of the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

In the financial years 2018-20 (2018-19 & 2019-20), her gross income is Rs.41,69,778/- and total deductions/Savings/investments against GPF, GIS, Income Tax, PPF, Repayment of home loan, PPF and Insurances are Rs.22,30,405/-. The balance of Rs.2,30,396/- has decreased from her saving bank A/c's against the balance of the previous year. Thus a sum of Rs.21,69,769/- (Rs.19,39,373/- from salary and Rs.2,30,396/- from saving bank account withdrawal) was therefore available with her to meet out the household expenditure of her family consisting three members in the financial years 2018-20 (2018-19 & 2019-20).

It is pertinent mention here that's Officer's Husband (Additional Director General- U.P. Police Cadre) having annual income was Rs.24,00,000/- for the financial years 2018-19 & Rs.26,00,000/- for the financial year 2019-20 respectively.

In this connection, it is submitted that the Officer has already submitted her property statement for the financial years 2016-18 offline (Misc. file of the officer) and same has been processed before Hon'ble Mr. Justice Piyush Agrawal, Administrative Judge, Basti Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. She had submitted movable and immovable property statements for the financial years 2018-20 (2018-19 & 2019-20) vide online dated 18.04.2022 on eServicesJo portal. As such, there is delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Smt. Chandra Sheela, Principal Judge, Family Court, Basti be laid before Hon'ble Mr. Justice Piyush Agrawal, Administrative Judge, Basti Judgeship for His Lordship's kind perusal and orders?
