May kindly see the property statement online received from Smt. Chandra Sheela, Principal Judge, Family Court, Basti regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family of the financial years 2020-22 (2020-21 & 2021-22) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2020-22 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

In the financial years 2020-22 (2020-21 & 2021-22), her gross income is Rs.43,88,906/- and total deductions/Savings/investments against Deposits in Saving Bank Account, GPF, GIS, Income Tax, PPF, Repayment of home loan and Insurances are Rs.24,51,379/-. The balance of Rs.7,64,095/- has increased from her saving bank A/c's against the balance of the previous year. Thus a sum of Rs.19,37,527/- was therefore available with her to meet out the household expenditure of her family consisting three members in the financial years 2020-22 (2020-21 & 2021-22).

It is pertinent mention here that's Officer's Husband (Additional Director General- U.P. Police Cadre) having annual income was Rs.26,00,000/- for the financial years 2020-21 & Rs.28,00,000/- for the financial year 2021-22 respectively.

In this connection, it is submitted that the Officer has already submitted her property statement for the financial years 2018-20 (2018-19 & 2019-20) online against case id-P00059712022 and same has been processed before Hon'ble Mr. Justice Piyush Agrawal, Administrative Judge, Basti Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2020-22 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. She had submitted movable and immovable property statements for the financial years 2020-22 (2020-21 & 2021-22) vide online dated 18.04.2022 on eServicesJo portal. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2020-22 (2020-21 & 2021-22) of Smt. Chandra Sheela, Principal Judge, Family Court, Basti be laid before Hon'ble Mr. Justice Piyush Agrawal, Administrative Judge, Basti Judgeship for His Lordship's kind perusal and orders?
