May kindly see the property statement online received from Sri Ankit Kumar Mittal, Additional District & Sessions Judge(FTC), Maharajganj regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2019-21 (17.03.2020 to 31.03.2020 and 01.04.2020 to 31.03.2021) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2019-21 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years **2019-21 (17.03.2020 to 31.03.2020 and 01.04.2020 to 31.03.2021)**, Gross income (Salary Rs.17,81,122/- ,Petrol allowances Rs.50,808/-, Other allowances Rs.35,500/- & Interest Rs.21,882/-) Rs.18,89,312/- and total deductions/savings/ investment against NPS, GIS, PPF, Income Tax, Insurance, PM relief fund, SIP, Sukanya Samridhi Yojna and the balance of his savings bank account(s) is also enhanced by Rs.9,28,753/- in this financial year from previous year's balance, total of which is Rs.15,04,656/-. Thus, a sum of **Rs.3,84,656/-** was therefore available with him to meet out the household expenditure of his family consisting of four members in the the financial year **2020-21**.

It is pertinent mention here that Officer wife( Tution teacher) having annual income Rs.5,40,000/-.

In this connection, it is submitted that the Officer has already submitted his property statement at the time of Joining into U.P. Judicial Service online against P00003222021 (Old Case id-2331), which has been seen by Hon'ble Mr. Justice Mahesh Chandra Tripathi, the then Administrative Judge, Meerut.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2019-21 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. He has submitted movable and immovable property statements of the financial year 2019-21 (2019-20 & 2020-21) vide online dated 21.04.2022. As such, there is delay in submitting the same. In this regard, Officer stated that's due to pandemic situation, he was not able to submit the above mentioned statement on time, and as such he request that the said delay may kindly be condoned and his statements may kindly be accepted

May, therefore, if approved, property statements for the financial years 2019-21 (2019-20 & 2020-21) of Sri Ankit Kumar Mittal, Additional District & Sessions Judge(FTC), Maharajganj be laid before Hon'ble Mr. Justice Ajit Singh, Maharajganj for His Lordship's kind perusal and orders?
