May kindly see the property statement received online from Sri Arpit Goel, Judicial Magistrate, Mau regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2019-21 (2019-20 & 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2019-21 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below :

(1) In the financial years 2019-21 (2019-20 & 2020-21), Gross income is Rs.12,23,666/- and total deductions/savings/investment against GIS, NPS, Income Tax, PPF, PLI, car purchase and the balance of his savings bank account is also enhanced by Rs.43,519/- in this financial year from previous year's balance, total of which is Rs.8,37,786/-. Thus, a sum of Rs.3,85,880/- was therefore available with him to meet out his household expenditure in both of the financial years. It is pertinent to mention here that Officer's father is retired HJS Officer, having monthly income of Rs.90,000/- (approx), as mentioned by the Officer.

In this connection, it is submitted that the Officer has already submitted his property statement held at the time of joining into U.P. Judicial Service and the same has been approved online against Case Id : P00000482021 by Hon'ble Mr. Justice Vivek Agarwal, the then Administrative Judge, Lucknow Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2019-21 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. He has submitted his movable and immovable property statements for the financial years 2019-21 (2019-20 & 2020-21) firstly vide online dated 27.04.2022. As such, there is some delay in submitting the same from the part of the officer. In this regard, he has stated (in his verbatim) that "I beg to submit that my statement about movable and immovable property could not be submitted on time as ongoing COVID-19 pandemic caused delay in acquiring computation of total income from my Chartered Accountant. Furthermore, I could not take notice of the Hon'ble High Court Letter No.14325/IV-h-16/Admin-A-IV dated 03.12.2021 as I was on earned leave. I most humbly request the Hon'ble Court to pardon me for the delay in submitting the statement about movable and immovable property. I shall not repeat the same in future", as mentioned by the officer in his attachment letter.

May, therefore, if approved, property statements for the financial years 2019-21 (2019-20 & 2020-21) of Sri Arpit Goel, Judicial Magistrate, Mau be laid before Hon'ble Mr. Justice Chandra Kumar Rai, Administrative Judge, Mau Judgeship for His Lordship's kind perusal and orders?
