Thus, a sum of Rs.47,30,969/- was therefore available with him to meet out the household expenditure of his family consisting five members for both the financial years.

In this connection, it is submitted that officer has already submitted his property statement of the financial year 2018-20 online against Case id-P00002952020 and same has been approved by the Hon'ble Mr. Justice Mahesh Chandra Tripathi, the then, Administrative Judge, Meerut Judgeship

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2020-22(2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements of the financial years 2020-22(2020-21 & 2021-22) vide online dated 06.05.2022. As such, there is no delay in submitting the same.
