May kindly see the property statements online received from Sri Mohd. Ghulamul Madar, Spl. Judge (SC/ST, Pev.of Atroci Act), Hardoi regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2020-22(2020-21 & 2021-22) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2020-22(2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below-

(1) In the financial years 2020-22(2020-21 & 2021-22), Total income is Rs.67,95,467/- Gross Income from salary is Rs.48,65,467/- & other sources(PPF matured and Reliance Nippo Insurance Policy matured) is Rs.19,30,000/- and total deductions/repayment/ savings/ investment against GPF, GIS, Income Tax, PM Relief Fund, Insurance policies and SIPs and the balance of his savings bank account(s) is also enhanced for Rs.67,438/- this financial year from previous year's balance, Total of which is Rs.20,64,498/-. Thus, a sum of Rs.47,30,969/- was therefore available with him to meet out the household expenditure of his family consisting five members for both the financial years.

In this connection, it is submitted that officer has already submitted his property statement of the financial year 2018-20 online against Case id-P00002952020 and same has been approved by the Hon'ble Mr. Justice Mahesh Chandra Tripathi, the then, Administrative Judge, Meerut Judgeship

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2020-22(2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements of the financial years 2020-22(2020-21 & 2021-22) vide online dated 06.05.2022. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial year 2020-22(2020-21 & 2021-22) of Sri Mohd. Ghulamul Madar, Spl. Judge (SC/ST, Pev.of Atroci Act), Hardoi be laid before Hon'ble Mr. Justice Abdul Moin, Administrative Judge, Hardoi for His Lordship's kind perusal and orders?
