May kindly see the property statement received online from Sri Arun Kumar Pathak, Presiding Officer, Commercial Court, Lucknow regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2020-22 (2020-21 & 2021-22) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2020-22 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2020-22 (2020-21 & 2021-22), Total income from salary is Rs.49,15,101/- and total deductions/savings/investment/repayment against G.P.F., GIS, Income Tax, PPF, SBI policy, RD & Home loan is Rs.31,17,115/-. Thus, a sum of Rs.17,97,986/- was therefore available with him to meet out the household expenditure of his family consisting of four members in both of the financial years. And the balance of his savings bank account(s) is also reduced by Rs.1,17,017/- in this financial year from previous year's balance.

It is pertinent to mention here that his wife's annual income is Rs.3,57,850/- & Rs.4,55,670/- from teaching & boutique work for the financial year 2020-21 & 2021-22 respectively and his daughter's annual income from job is Rs.6,50,000/- & 5,40,000/- for this period, as mentioned by the officer.

In this connection, it is submitted that the Officer has already submitted his property statements upto the financial year 2018-20 and the same has been approved online against Case Id: P00008712020 by Hon'ble Mrs. Justice Sadhna Rani (Thakur), the then Administrative Judge, Maharajganj Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2020-22 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has submitted his movable and immovable property statements for the financial years 2020-22 (2020-21 & 2021-22) vide online dated 26.04.22. As such, there is no delay in submitting the same.
