May kindly see the online property statement received from Sri Gopal Upadhyay, Additional District & Sessions Judge, Muzaffarnagar regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2020-21 & 2021-22 in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2020-21 & 2021-22 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2020-21 & 2021-22, Total income is Rs.49,75,528/- (total Gross income is Rs.46,14,108/- and rental income is Rs.3,61,420/-) and total deductions/ repayment/ savings/ investment (for both the financial years) against GPF, GIS, Income Tax, Insurance policies, PPF a/c, Home loan, Sukanya Samridhi a/cs, Shares, Mutual Fund and the balance of his savings bank account(s) is also enhanced for Rs.3,17,875/- in this financial year from previous year's balance, total of which is Rs.35,52,835/-. Thus, a sum of Rs.14,22,693/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years.

It is pertinent to mention here that his wife is Advocate having annual income near about 5 lac.

In this connection, it is submitted that the officer has already submitted his property statements upto the financial year 2018-20 which has already been seen online by Hon'ble Mr. Justice Pankaj Naqvi, the then Administrative Judge, Shahjahanpur.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2020-21 & 2021-22 in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements of the financial years 2020-21 & 2021-22 firstly vide online dated 02.05.2022. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2020-21 & 2021-22 of Sri Gopal Upadhyay, Additional District & Sessions Judge, Muzaffarnagar be laid before Hon'ble Mr. Justice Piyush Agrawal, Administrative Judge, Muzaffarnagar Judgeship for His Lordship's kind perusal and orders?
