May kindly see the property statement online received from Sri. Robin Kumar, Civil Judge (Junior Division), Mainpuri regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2019-21 (2019-20 & 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2019-21 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2019-21 (2019-20 & 2020-21), Total income is Rs.23,81,220/- (Gross income from salary is Rs.2231220/- & from father is Rs.1,50,000/- and total deductions/ repayment/ savings/ investment against Income Tax, Car Loan EMI and the balance of his savings bank account(s) is enhanced by Rs.48,980/- this financial year from previous year's balance, total of which is Rs.4,25,111/-. Thus, a sum of Rs.19,56,109/- was available with him to meet out the household expenditure of his family consisting of two members in both of the financial years.

It is pertinent to mention here that his wife earned Rs.1,50,000/- in both the financial years by sale of painting & stiching work.

In this connection, it is submitted that the Officer has already submitted his property statements of at the time of joining online against Case id-P00028292021 and same has been moved before Hon'ble Mr. Justice Vipin Chandra Dixit, Administrative Judge, Mainpuri Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2019-21 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. He has submitted movable and immovable property statements of the financial years 2019-21 (2019-20 & 2020-21) vide online dated 30.04.2022. As such, there is delay in submitting the same. In this regard, officer has stated that he was new in Service due to which he was not aware about the rules of property statement. He seeks apology for the delay caused in submitting the property statement.

May, therefore, if approved, property statements for the financial years 2019-21 (2019-20 & 2020-21) of Sri Robin Kumar, Civil Judge (Junior Division), Mainpuri be laid before Hon'ble Mr. Justice Vipin Chandra Dixit, Administrative Judge, Mainpuri for His Lordship's kind perusal and orders?
