

**Registrar(J)(Budget)**

May kindly see the online property statements received from Sri Amit Kumar Tiwari, Additional District & Sessions Judge, Aligarh regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2017-18 & 2018-19 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2017-18 & 2018-19 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2017-18 & 2018-19, Total Gross salary is Rs.29,91,906/- and total deductions/ repayment/ savings/ investment (for both the financial years) against NPS, GIS, Income Tax, Home loan, Insurance policies, PPF a/cs, Sukanya Samridhi Account and Gold bonds Scheme Certificate are Rs. 14,15,638/-. Thus, a sum of Rs.15,76,268/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years. And the balance of his savings bank account(s) has also been reduced for Rs.5,44,337/- this financial year from previous year's balance.

In this connection, it is submitted that the officer has already submitted his property statement at the time of entering into Judicial Service, which had already been seen by Hon'ble Mr. Justice Sabhajeet Yadav, the then Administrative Judge, Ghazipur, placed in the misc. file of the officer. And a detailed offline note regarding property statements of the financial years 2009-10 to 2016-17, has also been laid before Hon'ble Mr. Justice Ajit Kumar, Administrative Judge, Aligarh Judgeship for His Lordship's kind perusal and orders, in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2017-18 & 2018-19 in its next financial year i.e., 2019-20 upto March 2020. He has submitted movable and immovable property statements of the financial years 2017-18 & 2018-19 vide online dated 05.05.2022. As such, there is delay in submitting the same.

May, therefore, if approved, property statements of the financial year 2017-18 & 2018-19 of Sri Amit Kumar Tiwari, Additional District & Sessions Judge, Aligarh be laid before Hon'ble Mr. Justice Ajit Kumar, Administrative Judge, Aligarh Judgeship for His Lordship's kind perusal and orders?
