May kindly see the property statement online submitted by Sri Amit Kumar Tiwari, Additional District & Sessions Judge, Aligarh regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2019-20 & 2020-21 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2019-20 & 2020-21 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2019-20 & 2020-21, Total income is Rs.36,61,232/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, Income Tax, NPS, PPF a/cs, Sukanya Samriddhi Account, Insurance policies, Home loans and the balance of his savings bank account(s) is enhanced for Rs.7,80,640/- this financial year from previous year's balance, total of which is Rs.22,63,926/-. Thus, a sum of Rs.13,97,306/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statement at the time of entering into Judicial Service, which had already been seen by Hon'ble Mr. Justice Sabhajeet Yadav, the then Administrative Judge, Ghazipur, placed in the misc. file of the officer. And a detailed offline note regarding property statements of the financial years 2009-10 to 2016-17, has also been laid before Hon'ble Mr. Justice Ajit Kumar, Administrative Judge, Aligarh Judgeship for His Lordship's kind perusal and orders, in the misc. file of the officer. And of the financial years 2017-18 & 2018-19, separate note has been made on e-service ID no.P00061052022.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2019-20 & 2020-21 in its next financial year i.e., 2021-22 upto March 2022. He has submitted movable and immovable property statements of the financial years 2019-20 & 2020-21 firstly vide online dated 05.05.2022. As such, there is delay in submitting the same from the part of the officer for which he has stated (in his verbatim) that "Due to my transfer from District Mathura to District Kushinagar at Padrauna in the month of August 2019 and later due to Covid-19 Pandemic Property related document could not be collected which were at my paternal Home in District Fatehpur. Thats why I Could Submit my property Statement of year 2019-2020 & 2020- 2021 on time. So I Humbly Pray to Hon'ble High Court of Judicature at Allahabad to condone This delay" mentioned in his reply dated 29.04.2023.

May, therefore, if approved, property statements of the financial year 2019-20 & 2020-21 of Sri Amit Kumar Tiwari, Additional District & Sessions Judge, Aligarh be laid before Hon'ble Mr. Justice Ajit Kumar, Administrative Judge, Aligarh Judgeship for His Lordship's kind perusal and orders?
