Judicial Service online against Case Id: P00004482021 (Old Case Id: 2482) and the same has been seen by Hon'ble Mr. Justice Surya Prakash Kesarwani, the then Administrative Judge, Lucknow Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial year 2019-2021 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. She has firstly submitted movable and immovable property statements of the financial year 2019-2021 (2019-20 & 2020-21) vide online dated 11.05.2022. As such, there is delay in submitting the same from the part of the officer for which she has stated in her letter as attachment dated 11.05.2022, that she is a newly appointed officer and the delay caused due to difficulty in collecting the relevant documents like bank pass book, form-16, ITR, Insurance etc. and receiving the information regarding to mention the correct details in desired property statements format, for which she apologizes. Further she assures that she will send property statements on time in future.
