May kindly see the property statement online received from Sri. Umesh Kumar-II, Spl. J. (SC/ST, Pev.of Atroci Act), Shravasti regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2020-22 (2020-21 & 2021-22) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2020-22 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2020-22 (2020-21 & 2021-22), Total income is Rs.44,11,180/- (Gross income from salary is Rs.43,97,930/- and post office A/C closer is Rs.13,250/- and total deductions/ repayment/ savings/ investment against NPS, GIS, Income Tax, PPF, LIC policy and the balance of his savings bank account(s) is enhanced by Rs.5,48,037/- this financial year from previous year's balance, total of which is Rs.22,39,009/-. Thus, a sum of Rs.21,72,171/- was available with him to meet out the household expenditure of his family consisting of four members in both of the financial years.

In this connection, it is submitted that the Officer has already submitted his property statements of the 2018-20 (2018-19 & 2019-20) online against Case id- P00008722020 and same has been approved by the Hon'ble Mr. Justice Subhash Chandra Sharma, the then,Administrative Judge, Shravasti.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2020-22 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements of the financial years 2020-22 (2020-21 & 2021-22) vide online dated 24.08.2022. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2020-22 (2020-21 & 2021-22) of Sri. Umesh Kumar-II, Spl. J. (SC/ST, Pev.of Atroci Act), Shravasti be laid before Hon'ble Mr. Justice Krishan Pahal, Administrative Judge, Shravasti for His Lordship's kind perusal and orders?
