The balance of Rs.1,73,705/- has increased from his saving bank A/c's against the balance of the previous year. It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2020-22 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements for the financial years 2020-22 (2020-21 & 2021-22) vide online dated 07.05.2022. As such, there is no delay submitting the same.
