

## **Joint Registrar(Judicial)(Budget)**

May kindly see the property statement online received from Sri Avinash Chandra Mishra, Additional District & Sessions Judge, Basti regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2010-11 & 2011-12 in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2010-11 & 2011-12 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below-

(1) In the financial years 2010-11 & 2011-12, total income is Rs.26,90,174/- (income from salary of Rs.17,55,999/-, SB a/c interests of Rs.42,517/- & her wife received Rs. 891658/- as maturity amount of FDR which has done by her parents as stridhan) and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, DCI/NPS, Income Tax, NSC, PPF a/c, FDRs and the balance of his savings bank account(s) is enhanced for Rs.11,09,275/- this financial year from previous year's balance, total of which is Rs.25,73,671/-. Thus, a sum of Rs.1,16,503/- was therefore available with him to meet out the household expenditure of his family consisting three members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial years 2009-10 which had already been seen by Hon'ble Mr. Justice Shabihul Hasnain, the then Administrative Judge, Hardoi in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2010-11 & 2011-12 in its next financial year i.e., 2012-13 upto March 2013. He has submitted movable and immovable property statements of the financial years 2010-11 & 2011-12 firstly vide online dated 08.09.2020. As such, there is delay in submitting the same from the part of the officer for which he has stated that "Due to heavy work and inadvertent mistake he could not submit the property statement on due time for which he regret and apologise. He promised that he shall be careful in future and shall submit the property statement on time." (mentioned in reply dated 05.01.2021).

May, therefore, if approved, property statements of the financial years 2010-11 & 2011-12 of Sri Sri Avinash Chandra Mishra, Additional District & Sessions Judge, Basti be laid before Hon'ble Mr. Justice Abdul Moin, Administrative Judge, Basti Judgeship for His Lordship's kind perusal and orders?
