May kindly see the property statements online received from Sri Ahmad Ullah Khan, Principal Judge, Family Court, Aligarh, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2020-22 (2020-21 & 2021-22) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2020-22(2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2020-22 (2020-21 & 2021-22), Total income from salary and other Sources is Rs.54,97,025/- (Income from salary Rs. 50,66,025/-, Income from Interest Rs. 2,65,000/-, Income from special pay Rs. 21,000/-, Amount Received from LIC Rs. 50,000/- and Amount Received from Sell of Share Rs. 95000/-) and total deductions/repayment/ savings/ investment against GPF, GIS, Income Tax, PPF, Insurance policy And the balance of his savings bank account(s) is also enhanced for Rs.8,37,073/- this financial year from previous year's balance, total of which is Rs.28,87,567/-. Thus, a sum of Rs.26,09,458/- was therefore available with him to meet out the household expenditure of his family consisting four members for both the financial years.

It is pertinent to mention here that wife of the officer Smt. Sharmeen Khan, is practicing as Lawyer, having income of Rs. 7,07,850/- in F. Y. 2020-2022.

In this connection, it is submitted that officer has already submitted his property statement of the financial year 2018-20 which has already been processed online before Hon'ble Mr. Justice Saral Srivastava, Administrative Judge, Aligarh, on case id no. P00005692020.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2020-22 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements of the financial years 2020-22(2020-21 & 2021-22) vide online dated 23.05.2022. As such there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial year 2020-22 (2020-21 & 2021-22) of Sri Ahmad Ullah Khan, Principal Judge, Family Court, Aligarh be laid before Hon'ble Mr. Justice Saral Srivastava, Administrative Judge, Aligarh, for His Lordship's kind perusal and order.
