In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2020-22 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2020-22 (2020-21 & 2021-22), his gross income from salary, arrears, DA and interests on FD are Rs.65,53,174/- (Rs.55,04,832/- from salary and Rs.10,48,342/- from arrears, DA, Interests on FD) and total deductions/Savings/investments Deposits against saving bank account, NPS, GIS, Income Tax and PPF are Rs.54,61,155/-. The balance of Rs.32,48,567/- has increased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.10,91,619/- was therefore available with him to meet out the household expenditure of his family consisting five members in the financial years 2020-22 (2020-21 & 2021-22).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial years 2018-20 (2018-19 & 2019-20) online against case id-P00053782022 and same has been processed before Hon'ble Mr. Justice Subhash Vidyarthi, Administrative Judge, Balrampur Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2020-22 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements for the financial years 2020-22 (2020-21 & 2021-22) vide online dated 21.05.2022. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2020-22 (2020-21 & 2021-22) of Sri Anil Kumar Jha, District & Sessions Judge, Balrampur be laid before Hon'ble Mr. Justice Subhash Vidyarthi, Administrative Judge, Balrampur Judgeship for His Lordship's kind perusal and orders?
