In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2020-2022 (2020-2021 & 2021-2022) of the officer concerned, details of income, deduction, savings, investment and expenditure made by him are given below:

(1) In the financial years 2020-2022 (2020-2021 & 2021-2022), Total income is Rs. 47,35,639/- (Income from salary is Rs.4187633/- and LIC Surrendered for Rs.5,48,006/-) and total deduction/ repayment/ savings/ investment/ against N.P.S., G.I.S., Income Tax, LIC, P.P.F, P.L.I, Medical Insurance, Car Loan Emi, Home Loan Emi, Sukanya Samridhi Yojna are Rs. 19,09,467/- (including enhancement of Rs. 99,003/- in his S.B. A/cs against the balance of the previous year). Thus, a sum of Rs.28,26,172/- was available with him to meet out the household expenditure of his family consisting four members in both of the financial years.

It is pertinent to mention here that his mother Smt. Krishna Pandey has earned Rs. 7,00,000/- through rent received from shopping complex, Agriculture and farming in the financial years 2020-2022.

In this connection, it is further submitted that officer has already submitted his property statement for the period of 2018-2020 online against case id-P00008822020 and same has been approved by Hon'ble Mr. Justice Salil Kumar Rai, the then, Administrative Judge, Faizabad Judgeship.

It is again submitted that as per policy/Court's Circular letter, the officer has to submit his property statement for the financial years 2020-2022 (2020-2021 & 2021-2022) in its next financial year i.e. 2022-2023 upto March 2023. He has submitted movable and immovable property statements of the financial years 2020-2022 (2020-2021 & 2021-2022) vide online letter dated 03.06.2022. As such, there is no delay in submitting the aforesaid property statements from the part of officer.

May, therefore, if approved, property statements for the financial years 2020-2022 (2020-2021 & 2021-2022) of Sri Amit Kumar Pande, Special Judge (SC/ST, Pev.of Atroci Act), Faizabad be laid before Hon'ble Mr. Justice Ajit Kumar, Administrative Judge, Faizabad for His Lordship's kind perusal and orders?
