May kindly see the property statement received online from Sri Randheer Singh, Chairman, Commercial Tax Tribunal, Lucknow regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2020-2022 (2020-21 & 2021-22) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2020-2022 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2020-2022 (2020-21 & 2021-22), the Gross income is Rs.65,31,558/- (Rs.52,57,158/- from Salary and Rs.12,14,400/- from House Rent & Rs.60,000/- from SB Interest) and total deductions/savings/investment against GIS, PPF, GPF, loan repayments, SIPs, Mutual Funds, Insurances and Income Tax is Rs.41,86,695/-. Thus, a sum of Rs.23,44,863/- was therefore available with him to meet out the household expenditure of his family consisting four members of the financial year 2020-2022 (2020-21 & 2021-22) and the balance of his savings bank account(s) is also decreased by Rs.7,44,155/- in this financial year from previous year's balance.

It is pertinent to mention here that his wife have annual income of Rs.60,000/- from Boutique, Handicraft.

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2018-2020 (2018-19 & 2019-20) online against Case Id : P00017552021 (Old Case Id : 3874) and the same has been processed before Hon'ble Mrs. Justice Sangeeta Chandra, Administrative Judge, Lucknow Judgeship for Her Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2020-2022 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has firstly submitted movable and immovable property statements of the financial year 2020-2022 (2020-21 & 2021-22) vide online dated 14.06.2022. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial year 2020-2022 (2020-21 & 2021-22) of Sri Randheer Singh, Chairman, Commercial Tax Tribunal, Lucknow, be laid before Hon'ble Mrs. Justice Sangeeta Chandra, Administrative Judge, Lucknow Judgeship for Her Lordship's kind perusal and orders?
