May kindly see the property statements online received from Sri Rakesh Vashisht, Special Judge (SC/ST Act, Pev. Of Atroci Act), Pilibhit regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2020-21 & 2021-22 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2020-21 & 2021-22 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2020-21 & 2021-22, Total income is Rs.42,91,461/- [Gross Salary of Rs.41,72,906/-, EL encashment of Rs.1,00,725/- and received dividend & equity amount of Rs.17,830/-] and total deductions/ repayment/ savings/ investment against TDS, NPS, GIS, loans, Insurance policies, PPF a/cs, Medical health Insurance policy, SIP and the balance of his savings bank account(s) is enhanced for Rs.2,82,228/- this financial year from previous year's balance, total of which is Rs.18,23,687/-. Thus, a sum of Rs.22,77,000/- was therefore available with him to meet out the household expenditure of himself for both the financial years 2020-21 & 2021-22.

It is pertinent to mention here that officer & his wife got decree of divorced on mutual consent on 02-11-20 under section 13(B) of the hindu marriage act & both the children will live with their mother. His wife is working in Uttrakhand Higher Judicial Services, therefore No maintenance has been demanded by her. The right to maintenance for them has been Voluntarily Relinquished by her.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial year 2017-18, which has already been seen by Hon'ble Mr. Justice Rohit Ranjan Agarwal, the then Administrative Judge, Pilibhit for kind perusal and orders on the detailed office note, in the misc. file of the officer and statement of the financial years 2018-19 & 2019-20 has been processed online on case ID P00062182022.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2020-21 & 2021-22 in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements of the financial years 2020-21 & 2021-22 vide online dated 24.06.2022. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2020-21 & 2021-22 of Sri Rakesh Vashisht, Special Judge (SC/ST Act, Pev. Of Atroci Act), Pilibhit be laid before Hon'ble Mr. Justice Shekhar Kumar Yadav, Administrative Judge, Pilibhit Judgship for His Lordship's kind perusal and orders?
