May kindly see the property statements online received from Sri Rakesh Vashisht, Special Judge (SC/ST Act, Pev. Of Atroci Act), Pilibhit regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2018-19 & 2019-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2018-19 & 2019-20, Total income is Rs.44,50,601/- [Gross Salary (including interim relief arrear of 7th pay Commission/ D.A. Arrear/ EL encashment/ ACP) of Rs.44,14,601/- and amount withdrawn from PPF a/c of Rs.36,000/-] and total deductions/ repayment/ savings/ investment against TDS, NPS, GIS, Car loan, Insurance policies, PPF a/cs, Medical health Insurance policy and SIP are Rs.19,94,531/-. Thus, a sum of Rs.19,94,531/- was therefore available with him to meet out the household expenditure of his family consisting four members for both the financial years 2018-19 & 2019-20. And the balance of his savings bank account(s) is also reduced for Rs.1,27,310/- this financial year from previous year's balance.

It is pertinent to mention here that his wife is ADJ/Registrar State Redressal Consumer Deharadun (Uttrakhand) having monthly salary is Rs.1,25,000/- per month approx.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial year 2017-18, which has already been seen by Hon'ble Mr. Justice Rohit Ranjan Agarwal, the then Administrative Judge, Pilibhit for kind perusal and orders on the detailed office note, in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-19 (firstly vide offline letter dated 16.08.2019 with the statement of 2017-18) & 2019-20 vide online dated 24.06.2020. As such, there is delay in submitting the property statements of the financial year 2019-20 from the part of the officer for which he has stated that "there is no wilful delay or error on the part of the applicant send it & uploaded the same with in time, according to C.L. It is also worth mentioning that property St. of 19-20 & 20-21 was uploaded on E service app on Dt. 28-02-22 in 3rd financial year. This objection was raised it is not as per 2 year block policy. Therefore, removing the objection raised, the applicant is reuploading the property St. for F.Y. 2018-2020 & 2020-2022 as per two year block policy. However, if there is any delay or error left, on the part of applicant apologies for the same" in the remark column of movable proforma.

May, therefore, if approved, property statements for the financial years 2018-19 & 2019-20 of Sri Rakesh Vashisht, Special Judge (SC/ST Act, Pev. Of Atroci Act), Pilibhit be laid before Hon'ble Mr. Justice Shekhar Kumar Yadav, Administrative Judge, Pilibhit Judgeship for His Lordship's kind perusal and orders?
