May kindly see the property statements online received from Sushri Sangeeta Gaur, Civil Judge (Junior Div.) Gorakhpur regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial years 2019-21 (2019-20 & 2020-21) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2019-21 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

In the financial years 2019-21 (2019-20 & 2020-21), Total income from salary is Rs.11,20,459/- and total deductions/ repayment/ savings/ investment against GPF, GIS, Income Tax, PPF and the balance of her savings bank account(s) is also increased for Rs.4,99,119/- this financial year from previous year's balance, total of which is Rs.8,16,531/- Thus, a sum of Rs. 3,03,928/- was therefore available with her to meet out the household expenditure of her family consisting two members in both the financial years.

It is pertinent to mention here that the husband of the officer is a Public Servant and his basic pay is Rs.34,500/-.

In this connection, it is submitted that the Officer has already submitted her property statement online at the time of joining and same has been processed online before Hon'ble Mr. Justice Siddhartha Varma, Administrative Judge, Gorakhpur .

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2019-21 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. she has submitted movable and immovable property statements of the financial years 2019-21 (2019-20 & 2020-21) firstly vide online dated 15.06.2022. As such, there is delay in submitting the same from the part of the officer for which he has stated that due to unfamiliar with proper proforma, rules & some disturbance caused by Covid-19 pandemic that's why she could not submit in due time for that she is deeply regretted. She also ensured that she will be careful in future.

May, therefore, if approved, property statements for the financial years 2019-21 (2019-20 & 2020-21) of Sushri Sangeeta Gaur, Civil Judge (Junior Div.) Gorakhpur be laid before Hon'ble Mr. Justice Siddhartha Varma, Administrative Judge, Gorakhpur Judgeship for His Lordship's kind perusal and orders?
