May kindly see the property statement online received from Sri Tej Pratap Tiwari , District & Session Judge, Gorakhpur, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2016-18 (2016-17 & 2017-18) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2016-18 (2016-17 & 2017-18) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2016-18 (2016-17 & 2017-18), Gross income from salary is Rs. 3973950/-) and and total deductions/repayment/ savings/ investment against GIS, Income Tax, Home loans, PPF a/cs , RD and LIC policies are Rs.2351763/-. Thus, a sum of Rs.1622187/- was therefore available with him to meet out the household expenditure of his family consisting three members for both the financial years. And the balance of his savings bank account(s) is also reduced by Rs.84,625/- in this financial year from previous year's balance.

In this connection, it is submitted that the Officer has already submitted his property statements upto the financial year 2014-16 which is currently processed online & a separate note has been made on case-id no. P00062222022 and the same is moved before Hon'ble Mr. Justice Siddhartha Varma, Administrative Judge, Gorakhpur for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2016-18 (2016-17 & 2017-18) in its next financial year i.e., 2018-19 upto March 2019. He has submitted movable and immovable property statements of the financial years 2016-18 (2016-17 & 2017-18) vide online dated 14/06/2022. As such, there is significant delay in submitting the same. Regarding this, in the property statement of the financial year 2018-2020 submitted online on case ID no. P00056142022 the officer has stated that delay occured due to bonafide mistakes, work load and frequent transfers and also submitted his apology.

May, therefore, if approved, property statements for the financial years 2016-18 (2016-17 & 2017-18) of Sri Tej Pratap Tiwari , District & Session Judge, Gorakhpur be laid before Hon'ble Mr. Justice Siddhartha Varma, Administrative Judge, Gorakhpur for His Lordship's kind perusal and orders?
